



# Request for Proposal (RFP) for 2021 Summer Program Fund

Funding Provided by Superintendent of Public Instruction, State of Washington (OSPI)

Developed and Administered by School's Out Washington (SOWA)

Applications are due on Wednesday, July 7, 2021 at 5:00 pm.

# Introduction

The Office of the Superintendent of Public Instruction (OSPI) is partnering with School's Out Washington (SOWA) to develop and administer the 2021 Summer Program Fund: a statewide funding opportunity for evidence-based summer programs in summer 2021. (An RFP for summer programs for summer 2022 will be released in October, 2021.)

Since spring 2020, the COVID-19 pandemic has compromised the abilities of families, schools and youth development organizations to fully and effectively meet the social, emotional, mental health and academic needs of students. Young people have been isolated by the limitations of virtual learning, and families have struggled with childcare. For young people who are furthest from educational justice, limited access to programs and services has compounded existing inequities.

In spite of hardships, youth development organizations have adapted their services to respond to the young people and families to whom they are deeply connected. As the pandemic eases, these organizations are well positioned to offer summer 2021 programs within their communities that will enhance social connections among young people that have been lacking during the pandemic, provide opportunities for physical and outdoor activities, and further the well-being of young people as Washington emerges from the pandemic.

## **RFP Overview**

This RFP is specifically for programs which will be implemented **this summer, 2021**. Approximately \$1 M will be available this cycle for program funding ranging from \$5,000 - \$25,000. Another RFP to distribute approximately \$4.5 M will be released in fall 2021 for summer 2022 programs. The summer 2022 process will allow more time for planning and application, and will support larger funding ranges.

The primary goal of this funding is to expand opportunities for young people furthest from educational justice<sup>1</sup> and support their engagement in summer programs. SOWA intends to conduct an equitable and

accessible process that will strengthen diverse organizations to deliver high-quality summer programs and expand access in underserved communities.

Specifically, programs must:

- Prioritize social connections among young people;
- Engage young people in physical and outdoor activities;
- Be in-person or mostly in-person. Some hybrid components or virtual participation will be allowed.

#### **Eligible Applicants:**

Nonprofit community-based organizations (CBOs), including religious organizations, will be prioritized for 2021 Summer Program funding. Small businesses and public agencies are eligible to apply. Parks departments and school districts are not eligible; OSPI has other funds dedicated to these entities. 2021 Summer Program funds will only be available to organizations that serve young people in Washington State. Funded programs must adhere to Washington State Department of Health protocols. Funds may not be used for religious activities.

Applicants must provide summer programming for school-aged young people, ages 4-21, who are enrolled in or receiving services provided by a K-12 school. Programming must be provided on multiple days and/or over multiple weeks, and must support social connections among young people by offering group activities. These funds may not be used for 1:1 programming.

Only one application will be accepted from each organization. The only exception will be for an applicant which also serves as a fiscal agent for another eligible organization. In those cases, each may submit an application.

#### **Timeline and Process:**

The timeline for application submission, application review and funding decisions is very tight. The online application will be available on June 23, 2021; applications are due on July 7, 2021 by 5:00 PM. Programs that are successful with their applications should receive notification of funding by early August. (A complete timeline is included below.)

The application requests brief descriptions about programs/organizations; demographics for young people served; demographics for staff, volunteers, leadership and board; and brief dropdown and narrative responses. Program will be asked to request funding of between \$5,000 and \$25,000. No budget forms are required.

Engagement and guidance from youth development stakeholders across the state has been critical to making this funding available. SOWA sought stakeholders' feedback in the development of the strategy and application, and peer reviewers will review all Summer 2021 applications.

Funding will be available in mid-to-late August. Successful applicants may apply funding retroactively to unfunded Summer 2021 Program expenses, incurred on or after July 1, 2021.

Applicants will be asked for dropdown responses and/or brief narrative for four priority areas:

- 1. Program engages young people furthest from educational justice.
- 2. Staff, volunteers, leadership and board are reflective of the priority populations served.

- 3. Program design supports social connections among young people and engages young people in physical and outdoor activities.
- 4. Applicant has a strong implementation plan in place and is prepared to implement summer 2021 programming.

## **Technical Assistance**

The Washington State Department of Commerce partners with a diverse network of trusted organizations to provide culturally relevant assistance to small businesses and nonprofit organizations. Applicants are encouraged to contact one of the organizations listed on the Commerce Small Business Resiliency Network webpage if they need assistance in applying for 2021 Summer Program Funds.

# **Proposal Review Process**

SOWA is pursuing expansive, statewide outreach to engage approximately 50 proposal reviewers, with a focus on recruiting strong regional and BIPOC (Black, Indigenous, People of Color) representation.


All reviewers will be asked to disclose conflicts of interest. Reviewer assignments will ensure that reviewers do not review proposals from programs/organizations in which they serve as a staff member, board member, or consultant. Reviewers will participate in anti-bias training, prior to beginning their proposal reviews. Reviewers will also receive training on the scoring rubric. SOWA will review all scoring for consistency once reviewers have completed their review and scoring process.

# **Geographic Distribution of Review Groups and Summer Program Funding**

The map below outlines six regions across the state, aligned with Washington's Department of Children, Youth and Families' (DCYF's) six administrative regions. SOWA will use DCYF's regions as a way to geographically divide the state when assigning proposal review groups and determining funding.

Goals for distribution of funding across the state will be anchored by two key data points specific to these regions: young people 18 and younger living in poverty; and BIPOC young people, 18 and younger. (Data are gathered from the American Community Survey, 2019.)

On the map below, the percentage allocation is based on the percentage of Washington's young people 18 and younger living in poverty and the percentage of Washington's BIPOC young people 18 and younger residing within each region. These data were weighted equally in determining these goals for distribution of funds by region. While these are goals for geographic distribution, meeting them will be contingent on the number of qualified and highly-rated proposals received for each region.



# **Proposal Review Criteria**

Four priority areas of the application will provide the structure for the review of proposals by peer reviewers. Using a scoring rubric, reviewers will assess how and to what extent:

1.	Program will engage young people furthest from educational justice.	35% of total score
2.	Individuals in the following groups are reflective of the priority population served: 1) program staff and/or volunteers working directly with young people; 2) program leadership; 3) volunteer board members	20% of total score
3.	Program will support social connections among young people and engage them in physical and outdoor activities.	25% of total score
4.	Program has a strong implementation plan for the 2021 Summer Program.	20% of total score

Upon reviewers' completion of proposal reviews and submission of final scoring rubrics, SOWA will review all results. In addition to reviewers' scores, SOWA will also consider equitable representation among priority populations statewide and equitable geographic distribution; as well as the number of young people engaged and the number of contact hours, when making funding recommendations to OSPI.

# **2021 Summer Program Funding**

Funding will be available to 2021 summer programs in all areas of the state, with emphasis on those that serve young people furthest from educational justice.

2021 Summer Program funding will range from \$5,000 to \$25,000. Successful applicants will receive a minimum of \$5,000 and a maximum of \$25,000 based on multiple criteria:

- Peer reviewer scores
- Geographic equity goals
- The amount of funding requested
- The number of young people engaged
- The number of contact hours

Successful applicants will be required to do the following:

- Sign a contract with School's Out Washington
- Provide evidence of sufficient liability insurance
- Complete forms to facilitate transfer of funds
- Verify receipt of funds
- Complete organizational profiles in **Elevate Washington**
- Submit a final narrative report
