



Request for Proposal (RFP) for 2022 Summer Program Fund

Funding Provided by Superintendent of Public Instruction, State of Washington (OSPI) Developed and Administered by School's Out Washington (SOWA)

Applications are due on Monday, December, 6, 2021 at 11:59 PM.

Introduction

The Office of the Superintendent of Public Instruction (OSPI) is partnering with School's Out Washington (SOWA) to develop and administer the 2022 Summer Program Fund. These funds are part of OSPI's twoyear investment in summer programs using American Rescue Plan/ESSER (Elementary and Secondary School Emergency Relief) resources. The primary goal of the Summer Program Fund is to expand opportunities for Washington youth furthest from education justice¹ to engage in summer programs in 2021 and 2022 that include social connections, and physical and outdoor activities.

Since spring 2020, the COVID-19 pandemic has compromised the abilities of families, schools and youth development organizations to fully and effectively meet the social, emotional, mental health and academic needs of students. Young people have been isolated by the limitations of virtual learning, and families have struggled with childcare. For young people who are furthest from educational justice, limited access to programs and services has compounded existing inequities.

In spite of hardships, youth development organizations have adapted their services to respond to the young people and families to whom they are deeply connected. As COVID-19's impact eases, these organizations are well-positioned to offer Summer 2022 programs within their communities that will enhance social connections among young people that have been lacking due to lockdowns and quarantines, provide opportunities for physical and outdoor activities, and further the well-being of young people as Washington emerges from the pandemic.

RFP Overview

The 2022 Summer Program Fund will build upon the lessons learned in the 2021 Summer Fund process. Working within tight constraints, \$1 million was distributed in August, 2021 to 62 successful applicants, from among the 277 organizations that applied. Funded programs received between \$5,000 and \$25,000.

For Summer 2022, approximately \$4.5 million will be available for program funding ranging from \$10,000- \$50,000. The process and timeline will accommodate larger awards and a greater number of

¹ For the purposes of the 2022 Summer Program Fund, young people furthest from educational justice are defined as including the following priority youth populations: youth in poverty, BIPOC (Black, Indigenous and People of Color) youth, migrant youth, refugee and/or immigrant youth, English language learners, youth experiencing homelessness, youth in foster care, LGBTQ youth, youth involved in the criminal justice system, and youth with disabilities.

funded applications. The 2022 Summer Program Fund will also offer a longer window for initial summerprogram planning and application submission.

SOWA will conduct an equitable and accessible process that will strengthen diverse organizations to deliver high-quality summer programs and expand access in underserved communities.

Eligible Applicants:

To be eligible to submit an application, organizations must confirm that their summer programs will include social connections and physical and outdoor activities. Please see **Eligible Programming** (below) for details.

Nonprofit community-based organizations (CBOs), including religious organizations, will be prioritized for funding. Small businesses and public agencies are also eligible to apply.

Funds to religious organizations may not support religious programming or materials, nor can participation in religious activities (such as prayers or lessons with a religious purpose) be a required component for youth participants.

Applicants considering applying as a small business should meet the definition of small business in <u>RCW</u> <u>19.85.020</u>, specifically:, "small business" means any business entity, including a sole proprietorship, corporation, partnership, or other legal entity, that is owned and operated independently from all other businesses, and that has fifty or fewer employees"

Parks departments and school districts are not eligible; OSPI has other funds dedicated to these entities.

Summer Program funds will only be available to organizations that serve young people in Washington State. Funded programs must adhere to Washington State Department of Health protocols.

To be eligible, applicants must provide summer programming for school-aged young people, ages 4-21, who are enrolled in or receiving services provided by a K-12 school. Young people do not need to be receiving summer-specific services provided by a K-12 school system, but they must be enrolled in or receiving services from a K-12 school at some point during the school year. Young people who are home-schooled may also be served by summer programs.

Only one application will be accepted from each organization. The only exception will be for an applicant which also serves as a fiscal sponsor ² for another eligible organization. In those cases, each may submit an application.

For organizations with multiple affiliates across the state, each affiliate would be able to apply, provided each has its own 501(c)(3) nonprofit tax status and its own tax identification number.

Eligible Programming:

² A fiscal sponsor is an established nonprofit with IRS 501(c)(3) tax-exempt status that agrees to receive funds on behalf of a nonprofit organization that does not have (or does not yet have) 501(c)(3) tax-exempt status. Applicants with a fiscal sponsor are required to submit a copy of the fiscal sponsorship agreement.

Acting on the direction of the state legislature, OSPI is committed to using these funds to strengthen **social connections** among young people and engage young people in **physical³ and outdoor activities.**

In the narrative, applicants will be asked to describe the social connections, physical activities and outdoor activities their program will include, and discuss why their summer program will be feasible to implement and how it will be responsive to the young people they serve.

2022 summer programming must be provided on multiple days and/or over multiple weeks. Because strengthening social connections among young people is a required component, summer programs that focus solely or primarily on 1:1 (one adult to one youth) activities would not meet the eligibility criteria. Programs must be in-person or mostly in-person. Some hybrid components or virtual participation will be allowed.

Timeline:

Engagement and guidance from youth development stakeholders across the state has been critical to making Summer Program Funding available. Prior to the release of the 2021 Summer Program Fund RFP, SOWA sought stakeholders' input on the development of the strategy and application. Upon completion of the 2021 funding cycle, SOWA gathered feedback from organizations that received funding, and those that did not, in order to inform this 2022 Summer Program Fund process. Comments from 2021 Summer Fund peer reviewers, and additional rounds of stakeholder meetings in early October, were essential to SOWA's ability to act upon lessons learned and continue to improve the Summer Program Fund approach.

The online application for the 2022 Summer Program Fund will be available on Thursday, November 4, 2021; applications are due on Monday, December 6, 2021 at 11:59 PM. Programs that are successful with their applications should receive notification of funding by mid-February, 2022. Funds will be released to successful applicants by mid-May, 2022. A workshop for successful applicants will be offered in March, 2022. (A more-detailed timeline is included below.)

Process:

2022 Summer Program Fund applications must be submitted online and in English. However, the RFP itself will be translated to Amharic, Arabic, Chinese Mandarin, Korean, Marshallese, Russian, Samoan, Somali, Spanish, Tagalog, Tongan, Ukrainian and Vietnamese. Information on accessing translated RFPs is available on SOWA's 2022 Summer Program Fund webpage.

The online process requires applicants to confirm their eligibility prior to submitting an application. The online application requests brief details and descriptions about applicants' summer programs, and organizations. Some of this information will be included in <u>ElevateWashington.org</u>.

Applicants' responses specific to their funding request will include dropdown options and brief narratives which address the three focus areas of the 2022 Summer Program Fund:

- 1. The program engages young people furthest from educational justice.
- 2. Staff, volunteers, leadership and board of the applicant organization are reflective of the priority populations served.

³ Physical activities are defined as opportunities for young people to actively move their bodies and expend energy.

3. The program defines and supports social connections, physical activities and outdoor activities for young people **AND** the program's implementation plan will ensure that these three program requirements are achieved and are responsive to the needs and interests of the young people served.

Applicants will be asked to provide a figure for the total operating expenses for their organization in its most recently completed fiscal year.

Applicants will request a funding amount of between \$10,000 and \$50,000.

No budget forms will be required.

Technical Assistance

SOWA will provide access to optional technical assistance (TA) to support organizations in determining eligibility for the 2022 Summer Program Fund, and in completing their applications. In addition to TA directly through SOWA, assistance will also be available through the Small Business Resiliency Network. The Washington State Department of Commerce partners with this diverse network of trusted organizations to provide culturally relevant assistance to small businesses and nonprofit organizations. Applicants interested in accessing technical assistance should consult the <u>2022 Summer Program Fund</u> webpage.

Proposal Review Process

In collaboration with partners across the state, SOWA is pursuing expansive outreach to engage approximately 60 proposal reviewers, with an emphasis on strong regional and BIPOC (Black, Indigenous, People of Color) representation. Reviewers most likely to be selected will be based in Washington. In addition to meeting criteria for representation from priority populations and experience with application reviews, reviewers must have regional knowledge and a thorough understanding of Washington's youth development ecosystem.

All reviewers will be asked to disclose conflicts of interest. Review group assignments will ensure that no reviewers are assigned to read proposals from programs/organizations in which they serve as a staff

member, board member, or consultant. SOWA will require anti-bias training and will discuss the application questions and the scoring rubric as part of mandatory reviewer training.

Reviewers will review proposals from within their own regions. Statewide partners who serve as reviewers will be distributed among groups across all regions

Reviewers will independently score approximately 20 applications. After independent scoring is complete, small groups of reviewers who scored the same proposals will discuss their rubric scores and agree on a consensus score for each application. Reviewer groups will be facilitated by lead reviewers.

School's Out Washington will guide the review process, including assisting lead reviewers, as needed, in facilitating review groups. Once review groups have completed a thorough review and scoring process, SOWA will review the scoring from across all groups.

Proposal Review Criteria

Three focus areas will provide the structure for proposal review. Using a scoring rubric, reviewers will assess how and to what extent:

1.	The program will engage young people furthest from educational justice.	35% of total score
2.	Individuals in the following groups are reflective of the priority population served: 1) program staff and/or volunteers working directly with young people; 2) program leadership; 3) volunteer board members	20% of total score
3.	The program defines and supports social connections, physical activities and outdoor activities for young people AND the program's implementation plan ensures that these program requirements are met, and are responsive to the needs and interests of the young people served.	45% of total score

Along with reviewers' scores, equitable representation among priority populations statewide, equitable geographic distribution, the number of young people engaged, and the number of contact hours, will all be criteria in SOWA's review. Among competitive applications that meet the review criteria, small organizations will receive added consideration in SOWA's final funding recommendations to OSPI.


Geographic Distribution

The map below outlines six regions across the state, aligned with Washington's Department of Children, Youth and Families' (DCYF's) six administrative regions. SOWA will use DCYF's regions as a way to geographically divide the state when assigning proposal review groups and determining funding.

Goals for distribution of funding across the state will be anchored by two key data points specific to these regions: young people 18 and younger living in poverty; and BIPOC young people, 18 and younger. (Data are gathered from the American Community Survey, 2019.)

On the map below, the percentage allocation is based on the percentage of Washington's young people 18 and younger living in poverty and the percentage of Washington's BIPOC young people 18 and

younger residing within each region. These data were weighted equally in determining these goals for distribution of funds by region. While these are goals for geographic distribution, meeting them will be contingent on the number of qualified and highly-rated proposals received for each region.



Program Funding

Funding will be available to 2022 summer programs in all areas of the state. 2022 Summer Program funding will range from \$10,000 to \$50,000. Applicants will be asked to request a funding amount within this range; however, the funding received may be less than requested.

Successful applicants will be required to do the following:

- Sign a contract with School's Out Washington. A <u>sample contract</u> is included here, for information purposes only. Please be aware the final contracts may have slight variations from the sample contract. If that is the case, changes will be highlighted for selected applicants before contract signatures are required.
- Provide evidence of sufficient liability insurance.⁴ Details on insurance requirements are included in the <u>sample contract</u>

⁴ Organizations funded through the 2022 Summer Program Fund will be considered subcontractors of SOWA in SOWA's contract with OSPI. As such, funded organizations must carry insurance that meets OSPI requirements, including liability insurance that meets contracted limits, workers' compensation insurance, and auto insurance (as
