Organizations with Training Opportunities and Resources to Support Nonprofit Fundraising and Capacity Building in Washington State

Puget Sound Grantwriters Association - https://www.grantwriters.org/

Area served: Washington State, mostly in King and Pierce counties

The Puget Sound Grantwriters Association promotes responsible, effective grant-seeking and fosters connections among grant seekers, non-profits, and funders. PSGA is a membership organization with annual membership dues of \$95, providing discounted or free access to training and resources. Some of their offerings available to members and nonmembers:

- PSGA Lunchtime Programs provide grant writers and nonprofit fundraisers informal
 opportunities to learn about current trends and issues that impact their work. Speakers and
 panelists will include grant makers, seasoned grant writers, and others who are connected to
 the nonprofit fundraising world.
- The Funders Forum is hosted twice a year by PSGA. The Seattle Funders Forum in the spring, focusing on funders working in the Seattle area, and the South Sound Funders Forum in the winter, focusing on the South Sound area (Tacoma, Olympia, etc.).
- Directory of freelance grant writers with experience, areas of expertise, and other background information.
- Resources for learning how to write grants and other grant writing-related topics.

Communities Rise - https://communities-rise.org/

Area served: King County, focus on BIPOC communities and supporting small community-based organizations.

Communities Rise fosters movements to build power in communities impacted by systemic oppression. To create an equitable system, we pursue cross-sector collaboration and provide capacity-building and legal services for community organizations and small businesses. Communities Rise offers a range of services, including trainings, clinic opportunities, and cohort models of support. Some of the topics supported include:

- Grant writing and fundraising clinics
- Direct legal services and access to resources and toolkits on a variety of topics related to nonprofit governance and structure.
- A range of toolkits on topics from fiscal sponsorship to alternative leadership models.

Library System Supports

Seattle Public Library

Support nonprofits and grantwriters with free resources, services, and customized assistance. Librarians are available by email or appointment to help locate grant opportunities, conduct planning and proposal research, build nonprofit skills, and connect with local experts. Some of the offerings include the following.

- Access to the grants database Foundation Directory Online to help identify potential funders
 and grant opportunities. FDO is accessible on any public internet computer at the Central Library
 and on your own device while connected to the Central Library wi-fi network. FDO is not
 accessible remotely or at branch libraries. If you are not able to visit the Central Library, you may
 make a grant research appointment on the SPL website.
- Library to Business program gives free access to valuable research and databases that provide information about market trends, and other important nonprofit planning and proposal research resources.
- Nonprofit guides on a variety of topics including starting a nonprofit, nonprofit grantwriting, and nonprofit fundraising.

Spokane County Library District

NAWA is a membership organization whose annual dues amount is based on annual budget size. See their website for more information about membership. NAWA offers the following services:

- Learning opportunities include nonprofit management and leadership-focused workshops offered in communities across the state, resources, and toolkits. Topics include tax basics for nonprofits, legal resources, an understanding of nonprofit financials, strategic planning in nonprofits, Board governance, leadership transition, and much more.
- Advocating at the local, state, and federal levels for laws and policies that create a positive climate for all types of nonprofits. NAWA seeks to improve partnerships between nonprofits, governments, and communities at all levels. NAWA also has resources on how organizations can engage in more advocacy and public policy work.
- Collaborating at the regional level by supporting networks across the state to build strategic
 partnerships, many of which meet monthly or bi-monthly to forge connections, share resources,
 and discuss relevant topics. NAWA also convenes affinity groups to foster learning and mutual
 support and supports a network of paid, part-time outreach workers through the Equity
 Ambassadors program to connect with people across WA state, prioritizing individuals with lived
 experience and connection to BIPOC, immigrants, rural, LGBTQ+, and disability communities.
