
Welcoming refugees is a collective effort.

- Other State Agencies
















U.S. Refugee Admissions Program

Uniting for Ukraine (U4U)

On April 21, 2022, President Biden announced Uniting for Ukraine, a new streamlined process to provide Ukrainian citizens and their immediate family members who have fled Russia's unprovoked war of aggression opportunities to come to the United States and stay temporarily, with a period of parole up to two years. Ukrainians participating in Uniting for Ukraine must have a supporter in the United States who agrees to provide them with financial support for the duration of their stay in the United States. 243,088 U4U supporter applications filed,

165,000 U4U beneficiaries approved for travel,

128,000 U4U arrivals paroled into the United States,

Ukrainian Arrivals in Washington January 2022 - March 2023


17,403 Ukrainians have arrived in Washington and received cash, food, and/or medical assistance from DSHS.

New Pathways for Refugees and Immigrants

Welcome Corps – Private Sponsorship

Designated for refugees
Group of five adults that pass security screenings
Min. of \$2,375 per refugee
Provide basic supports for up to 90-days, including long-term housing
Make connections to local services
Receive training and supports

Supporter Processes Programs

Available for people from Cuba, Haiti,

Nicaragua, Ukraine and Venezuela

Have a supporter in the U.S.

Must be outside the U.S.

Undergo and pass security and screening

Receive travel authorization and enter as

humanitarian parolees

Only Cubans, Haitians and Ukrainians are eligible for federal benefits and refugee services
